Mary suggested that we purchased two new picnic table for down at the beach. Susan suggested a few more rest benches on the ski trail. Eric wants and needs a plan for placement of equipment.

Pam gave a report on the donation plan and handed out pledge forms for the Tomahawk Lake Park Improvement Project and these can be picked up at the Town Office. There is currently \$1,100 in the fund. Paving for parking in the future has a balance of \$2,400. This includes the \$1,100.

Jill gave a report on dance classes. There will be six Tuesdays from 3-5 pm on November 7, 14, (skip the 21<sup>st</sup>) and 28 and December 5, 12, and 19.
