**11.Matt Berg Survey Results (Tomahawk, Sandbar, George) – Ingemar, Gus** Ingemar reported that he and Matt Berg pent 7 hours surveying the three lakes. Findings: on Tomahawk in the shallower bay (east side)and found milfoil., the patches have grown larger, taller. Surveyed the perimeter, of Sandbar Lake and found milfoil all around the lake, larger patches in some areas. George Lake, concentrating on south end of lake, no milfoil found Mapping on the three lakes will be coming from Matt Berg, along with his bill.
